- Title:** The Society of Uroradiology Research Awards
- Amount:** The Society will annually designate a maximum of \$10,000 for research projects
- Eligibility:** Members of the Society of Uroradiology
- Deadline:** Friday, October 1, 2010
- Guidelines:** Research funding will be for amounts between \$3,000 and \$10,000 annually, renewable for up to 3 years duration based upon satisfactory review of annual progress as reported to the Society and members at the Scientific Session of the SUR.
- Renewal funding requests will compete with new funding requests.

GUIDELINES AND INSTRUCTIONS**

1. Application deadline: **Friday, October 1, 2010.**
2. Award will be announced during the 2011 Society of Uroradiology Meeting and/or Scientific Session of the 2011 Abdominal Radiology Conference (ARC) meeting.
3. The applicant must be a member of the Society of Uroradiology. All members are eligible.
4. Proposals should be relevant to the field of genitourinary radiology and may focus on basic science, clinical radiology, health services research or contrast material.
5. Applications should be no longer than three (3) typewritten pages (approx. 1,000 words or less). Additional supportive attachments are acceptable.
6. Applications should be submitted electronically to info@uroradiology.org, please note that electronic signatures will be accepted.
7. Please fill out the attached face sheet.
 - (a) Application should include: specific aims, background and significance, research design and methods, literature cited (do not exceed 15 references).
 - (b) Attach biographical sketch (two-page NIH format preferred) AND a separate page detailing sources of current funding for each member of the study.
 - (c) A detailed budget must be included. If budget exceeds \$10,000, please identify other sources of funding.
8. The Society will annually award a maximum total of \$10,000. Individual Awards will range from \$3,000 - \$10,000. Award funds are to be applied to direct costs only and may not be applied to institutional overhead or any other indirect costs. The grant will not support travel expenses or salary for Principal Investigator.
9. SUR Research Awardees may apply for continued funding of an ongoing project through the annual application process, the submission of a written progress report to the Board and a presentation to the members at the SUR scientific session.
10. Incomplete proposals or proposals not following these guidelines will not be considered and will be returned.
11. Grants will be judged on proposal originality, scientific or clinical relevance and research plan. An interdisciplinary approach is encouraged.
